Windshield Protection (Glass Breakage) Limited Warranty

Various provisions in this Windshield Protection Limited Warranty restrict coverage. Read the entire Agreement carefully to determine Our and Your rights, duties and what is and is not covered. Throughout this Agreement, the words "you" and "your" refer to the original retail purchaser of the Invisible Windshield Protective Film "Product" applied to the above described vehicle only. The words "we", "us", and "our" refer to ClearPlex Corporation, PO Box 216, Draper, Utah 84020.

Description of Coverage: We, the manufacturer of the Product, provide you, the original retail purchaser of the Product, the following Limited Warranty as follows: **Please read this document carefully as there are specific requirement, repair facilities, photographs and Product preservation requirements required of you, before we will pay any claims hereunder.**

Limited and Extended Warranty Coverage:

Windshield Protection Warranty: This Limited Warranty covers the repair or replacement of the above described vehicle's windshield if (a) the Product was installed on the above described vehicle at the time of impact, (b) the windshield had no pre-existing damage, (c) the Product fails to protect the windshield from chipping, cracking or breaking, (d) during the coverage period when applied to an approved class of vehicles for an approved use under normal and proper use of the Product, (f) and the Product has been properly maintained and protected by you according to our published maintenance and protection specifications, (g) subject to the limitations and exclusions set forth herein. **This Limited Warranty will only consider claims where the damage to the windshield is immediately behind a visible and discernible impact point on the Product surface.**

Windshield Protection Warranty Coverage Option of the Life of the Coverage with ClearPlex Film: This Limited Warranty, together with all warranties implied by law and not excluded herein, shall be limited to the time that the first installation of ClearPlex Film is on the vehicle, which is normally for one year, but can be longer if the condition of the film allows that to be the case. This Limited Warranty expires when the ClearPlex film is removed from the windshield for any reason whatsoever. This Limited Warranty is only valid to you, and is not transferable or assignable, by operation of law or otherwise.

Limitations and Exclusions under the Windshield Protection Warranty:

We do not cover and specifically exclude damage to the Product or windshield for the following reasons or conditions:

Exclusions: We do not cover loss to the Product or windshield resulting from the following: (a) sandstorms, hail, tornadoes, hurricanes, (b) any use of the vehicle on dirt roads, mining roads, gravel roads (off-road), (c) chemicals and caustic materials, (d) falling objects, (e) normal wear, accident, collision, negligence, misuse, abuse, neglect, mishandling, alteration, maladjustment, modification, customization, or vandalism, (f) pre-existing damage, intentional damage to the windshield, (g) cleaning or scrubbing the Product on the windshield with abrasive material, (h) fraudulent claims, (i) products not supplied by us, (j) service by anyone other than us or an installer approved by us, (k) misapplication, faulty installation, installation methods or any installer action or inaction, (l) minor chips or damage to the windshield, where the windshield, if not repaired does not violate the vehicle code of your State, (m) cosmetic damage, (n) any claim, where at a minimum, a photograph from an approved inspection facility has not been provided to us.

Limitations: This Warranty is subject to the following and limited by the following. No agent, representative, installer, dealer or employee has the authority to alter, extend, limit, modify, or increase the obligations or limitations of this Limited Warranty. The installer of the Product is NOT an employee or agent of ours and the installer is solely responsible to you for any claims, modifications or repairs made to your vehicle as a result of the installation of the Product. We do not cover any acts of omissions of the installer.

Secondary Coverage: This warranty is secondary to any other valid and existing insurance coverage on the vehicle windshield. If at the time of loss, the damaged windshield is covered by any other valid and existing insurance, either yours or a third party, we shall have no obligation under this warranty. If the primary insurance does not cover any portion of the windshield replacement cost due to an insurance deductible, and we are responsible for the loss as defined herein, we will pay the amount the primary insurance company does not cover up to an amount not to exceed \$1,500, if the damage was as a result of our Producer's failure to perform as warranted. We will cover the cost of OEM windshield replacement if the damaged windshield is an OEM windshield. We will cover the cost of aftermarket windshield if the damaged windshield is an aftermarket windshield.

Repair or Replace: During the Windshield Protection Warranty period, if applicable, you must fill out the claim form at www.clearplex.com and return that form to ClearPlex Corporation. If we are obligated under any claim arising hereunder, we have the right to repair or replace the Product or windshield in our sole discretion. **We are not responsible for the cost of re-installation of the Product, only the Product itself.**

Requirement to Contact Us First: IF WE ARE RESPONSIBLE FOR REPLACING YOUR WINDSHIELD UNDER THE PROVISION OF THIS WARRANTY, YOU MUST CALL US FIRST BEFORE REPLACING OR REPAIRING THE WINDSHIELD. WE WILL DIRECT YOU TO AN APPROVED WINDSHIELD PROVIDER UNDER CONTRACT WITH US. ANY REPAIRS OR REPLACEMENTS MADE WITHOUT OUR PRIOR APPROVAL WILL NOT BE COVERED UNDER THIS WARRANTY.

However, in no event shall we (or the installer's) liability under any claim or theory exceed (a) the purchase price of the Product if the Product requires replacing, and/or the windshield dollar limitation set forth herein if the windshield requires replacing.

Manufacturer's Defect Warranty: We, the manufacturer, warrants to the original retail purchaser of the Product that when the Product is used for its intended purposes, that it is free of discernible manufacturing defects. This limited warranty, together with all warranties implied by law and not disclaimed by this warranty, if any, shall be **limited to a period of 18 months or 18,000 miles, whichever comes first, from the date of purchase by the original retail purchaser.** This warranty is only valid to the original retail purchaser and is not transferable or assignable, by operation of law or otherwise.

We do not cover and specifically exclude damage to the Product or windshield for the following reasons or conditions:
